EXECUTIVE SUMMARY

High quality palliative care is best informed by methodologically strong research efforts that generate a strong and robust body of evidence. Developing such an evidence base is a necessity due not only to its capacity to support and direct care, but also to effect changes in practice.

The PCAU Research Agenda (RA) provides focus and direction for Palliative Care Research and strategic information by the Palliative Care Association of Uganda (PCAU). The development of the research agenda was accomplished through a consultative process covering a wide range of stakeholders and is aligned to the PCAU strategic plan (2022-2026), APCA's 2020-2030 strategic plan and Uganda Ministry of Health's specific objective four of the HSDP 2015-2020. The RA is a basis for research, resource prioritization and information sharing and will provide evidence-based solutions to PC service provision. Working in partnership will be central in achieving its objectives.

In order to become a hub for PC research in Uganda, PCAU research agenda will be guided by the following strategies

- 1. Grow PCAU in the international stature and enhance international exposure and opportunities for collaboration which will be achieved through:
 - Finalizing and actualizing the research agenda on palliative care.
 - Developing a research policy for PCAU.
 - Publishing research studies on palliative care.
 - Developing a peer-reviewed journal on palliative care.
 - Increasing and mobilizing research funding at PCAU.
 - Establishing a physical and digital information center for PCAU.
 - Establishing the PCAU digital information palliative care App.
 - Conducting the Biennial PC conferences.
- 2. Enhance PC capacity and skill development that meets the needs of patients and their families through:
 - Conducting periodical research studies on PC.
 - Strengthening research collaboration, learning and adaptation with relevant stakeholders.
 - Adoption and integration of innovative and efficient interventions
 - Structured dissemination of palliative care research and information.
- 3. Strengthen monitoring and evaluation by fast-tracking the audit of the Human Resources for Palliative Care demand and supply in the public and Private health Sector through:
 - Establishing a Research Ethics Committee for PCAU.
 - Strengthening the management of National PC data
 - Creating and publishing the biennial Uganda palliative care Directory.

The RA will address the urgent need for palliative care research that informs practice and policy. It will as well strengthen collaboration between palliative care practitioners within the country to better position them for global opportunities that are available.

A. BACKGROUND

According to the World Health Organisation (WHO), Palliative Care (PC) is an approach that improves the quality of life of patients (adults and children) and their families who are facing problems associated with life-threatening illness.

The Palliative Care Association of Uganda (PCAU) is a civil society organisation established in 1999 to support and promote the development of palliative care and palliative care providers in Uganda the PCAU strategic plan for 2022-2026 has five focus areas:



The strategic objective of focus area three is "To be a hub of research and information, through the carrying out and/or hosting relevant Palliative Care (PC) research and leading the collection, storing, analysis of data and by regularly disseminating information to improve PC services." A key result under focus area three is to "Articulate and publish the PCAU research agenda."

The development of the Research and Information Agenda was a participatory process. Representatives from member organizations, APCA, MoH and other partners, as well as PCAU staff, contributed ideas in a brainstorming meeting, a zoom meeting and by completing an online questionnaire. The data generated from the brainstorming and from the questionnaires as well as from the zoom meeting was then used to synthesize a draft agenda with themes and suggested research questions. The draft agenda was presented to the PCAU board who suggested modifications before the final document.

B. REVIEW OF KEY ACHIEVEMENTS & CHALLENGES

Achievements

The strategic plan (SP) which had Research as one of its foci had several achievements from 2017 – 2021 which included:

- Recruitment of a Research officer who established a research desk at PCAU.
- > Conducting and/or hosting -specific research projects and activities.
- Scaling-up of the m-Health program which promoted improvement of national data collection on PC and inclusion of PC service indicators in the national Health Management Information System.
- > Publishing of the PC Newsletter and regular update of the PCAU Website
- Organizing Biennial National Conferences on cancer and palliative care to bring together partners and stakeholders to in Uganda and share best practices.

It is a basis for research, resource prioritization and information sharing. The research agenda will assist in providing evidence-based solutions to PC service provision in Uganda.

Goal: The goal of this Research Agenda is to document palliative care areas with limited evidence and undertake research activities that will address the issues surrounding those areas.

Strategies

Mobilization, gathering and allocation of financial resources is essential for provision of palliative care services. Research to understand the current and the potential financial sources will provide evidence for technology and innovation as well as resource mobilization for palliative care in Uganda. Human resources for Human resources are the most important input for palliative palliative care care services' provision. To be able to conduct relevant research and use the findings in evidence-based PC decisions depends on the availability of people with relevant knowledge, skills, and motivation Palliative care education This strengthens the provision of quality palliative care services through trainings, continuous professional education, mentorship, and support supervision Palliative care for children Children are vulnerable because they are totally dependent on others and have very limited autonomy. Children have distinct PC needs but the service is limited. Research Agenda Review and Evaluation

The RA will be reviewed annually to inform the planning and budgeting process. The RA will be evaluated by conducting an independent midterm review and a summative evaluation at the end of 5 years.

E. RESEARCH PROCESS

Steps

- **Solicitation:** PCAU will disseminate the RA widely among members of the academia and partners. All application and consultations for research shall be made through the PCAU Research and Information committee / department.
- **Eligibility**: PCAU will receive concepts from researchers (individuals/institutions/organizations) who may be from Uganda or from other countries.

Research grants will be eligible for only Postgraduate candidates undertaking research in line with the research agenda.

- **Selection criteria:** Topics which are aligned with the PCAU research agenda shall be prioritized. The researchers will be encouraged to collaborate with the PCAU research office to develop a full proposal.
- Ethical considerations: All proposals shall be submitted to an accredited Research Ethics Committee for ethical approval. PCAU shall support the researcher in seeking permission from relevant offices to permit data collection. Data collection and report writing will then be proceed followed by dissemination of findings.
- Dissemination: The dissemination may be through stakeholder meetings, newsletters, and conferences. Publications in peer reviewed journals shall be prioritized as a dissemination channel.

F. RESEARCH GRANTS

- **Solicitation;** PCAU will also offer research grants to candidates undertaking PC research. Advertisements for research grants will be done online only when there is availability of fund. All applications for research grants shall be made through the PCAU Research and Information committee/department.
- **Eligibility**: PCAU will receive concepts from researchers (individuals/institutions/organizations) who will be from Uganda.

Research grants will be eligible for only Postgraduate candidates undertaking research in line with the research agenda.

- **Selection criteria:** Topics which are aligned with the PCAU research agenda shall be prioritized.
- Notification of outcome: upon receipt of the application, the applicant will be notified and given information on when to expect feedback from the Research and Information committee / department.
